

# TEXAS ASSOCIATION OF QUILT GUILDS GRANT APPLICATION

The Texas Association of Quilt Guilds shall grant \$1,000 per year in increments of \$100.00. Grants will be awarded only to member guilds. Funding will be limited to one grant per applicant per year.

TAQG will make funds available to its member quilt guilds to pursue projects relating to quilting that promote and enhance skills needed for new and experienced quilters: for example - education, history, research and development. Grants may not be used to pay for labor costs.

The benefits of these grants will positively impact young people, new quilt guilds and even a group of Member Guilds.

## GRANT FUNDING EXAMPLES

**Education Projects:** postage, printing, materials and travel expenses for a team to present programs on quilting in schools or nursing homes, to deliver certain mentoring efforts especially to small member guilds, provide continuing quilting education via speakers, classes, workshops and scholarships.

**Historical Preservation Projects:** postage, printing, copying costs for videos of local quilting celebrities in your town - a living history idea, documenting local quilts.

**Research and Development Projects:** creating videos.

The Grant Committee will administer the grant process by

- a. Distributing the necessary application forms
- b. Collecting the completed application forms
- c. Reviewing the applications d.

Making recommendations

The TAQG Executive Board shall make the objective, final decision for Grant Approval to qualified applicants.
